

THE INFORMATION CLAUSE ON THE PROCESSING OF PERSONAL DATA

In accordance with the article 13 of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) hereinafter referred to as Regulation, we inform that:

- 1) The Administrator of Your personal data provided in the registration form is **Lublin University of Technology, ul. Nadbystrzycka 38D, 20-618 Lublin;**
- 2) The Inspector of Data Protection in **Lublin University of Technology in Lublin** is **Tomasz Joński**, e-mail address: **t.jonski@pollub.pl** (You can contact the personal data inspector on all matters relating to the processing of personal data and the use of data processing rights);
- 3) personal data provided in the registration form are processed in order to register participation in **11th International Conference New Electrical and Electronic Technologies and their Industrial Implementation 2019, (NEET 2019)**, organized on 25-28.06.2018. by the Department of Electrical Devices and High Voltage Technology, Faculty of Electrical Engineering and Computer Science, Lublin University of Technology in Lublin, in organizing and communicating with participants on matters related to the organization of the conference, documenting its course, including drawing up a list of participants, issuing certificates of participation (at the request of the participant), archival purposes, to the extent resulting from the registration form (located at <http://neet.pollub.pl/rejestracja.php>) and in the event of consent to receive information about conferences and events about the scientific profile or popularizing science organized by the Lublin University of Technology - also in order to send such information in the future. The legal basis for the processing of personal data is Article 6, paragraph 1 (a) GDPR, or consent;
You may withdraw your consent at any time - which does not affect the legality of the processing carried out prior to its withdrawal;
- 4) the personal data provided by you will not be disclosed to other entities, except for entities authorized by law, including those involved in the organization or operation of the conference;
- 5) the personal data collected in connection with participation in the conference will be processed during the period of storage of financial and accounting documentation of the conference by the university, in situations provided for by law may also be processed within the period necessary to establish and seek possible claims. In the event of consent to receive information about conferences and events with a scientific profile or popularizing science, personal data will be processed until the consent is withdrawn or the opposition to the data processing is withdrawn. 6) the data subject has the right to access their personal data and the right to rectify, delete or limit the processing, the right to data transfer, the right to object to their processing, the right to withdraw consent at any time without affecting the legality of processing which was made on the basis of consent before its withdrawal;
- 7) In the case of finding that the processing of your personal data violates the provisions of the Regulation, you are entitled to bring a complaint to the supervisory authority, that is to the President of the Office for the Protection of Personal Data (PUODO);
- 8) in relation to your data, decision will not be taken in an automated way (article 22 GDPR), they will also not be profiled;
- 9) Your personal data will not be made available to a third country and to international organizations;
- 10) the event will be recorded and photographed for documentary and promotional purposes of the Lublin University of Technology. Participation in the conference is tantamount to consenting to the use of the image in film and photographic materials;
- 11) **providing data is voluntary, but necessary for the purposes for which they were collected, without their providing, participation in the conference will not be possible.**
